RULES GOVERNING SALE:

By entering animals for auction sale and by appearing and bidding on said animals, or by phone bidding, buyers and sellers subject themselves to the rules and conditions listed in this catalog, and they accept and agree to be governed by them, whether they read them or not.

HEALTH:

All horses will be subject to a short inspection by the veterinarian and his/her opinion stated. All horses will sell with a coggins and current health certificate and appropriate breeding information for mares with foals and/or bred. All horses will be subject to a short inspection by the Veterinarian who will state his/her opinion.

BIDS:

The official auctioneer shall be the judge of any dispute regarding bids and shall follow those rules of practice established in the profession.

The highest bidder will be the buyer, and if dispute arises between two buyers, or buyer's representative, the horse in dispute shall immediately be put up again for advance bids. If there be no advance, the horse shall go to the person from whom the auctioneer recognized the last bid. The Sales Management, Shining Mountain Foxtrotters, LLC, or auctioneer is authorized to decline any bid by intoxicated or disorderly parties, or from anyone who in their judgement is not a reliable or responsible party.

BUYERS:

Who provide letter of credit. Must have cash, cashier's check or personal check with current letter of credit. Personal check with current letter of credit U.S. funds only.

TERMS:

All prospective buyers must register with sales office before bidding. Driver's license or other ID needed. Terms of sale are cash and payment in full must be made to the sale personnel immediately after sale, and buyer must sign a buyer's receipt upon successful bid. All animals are property of the seller until the fall of the gavel at which time the animal/animals become the property of the buyer. Buyers must make payment in full upon successful bid, or immediately at end of sale. Shining Mountain Foxtrotters, LLC accepts or claims no responsibility for any injuries, accidents to persons or animals, nor for any thefts occurring upon sales ground.

MFTHBA PAPERS: Will be signed over immediately upon receipt of cash or cashier's check. Papers will be mailed to purchaser upon clearance of personal checks.
